**Agri-Starter** is corrosive to aluminum, mild steel and brass.

### DIRECTIONS FOR USE

Always make a small scale test to assure compatibility in your material. Then add **Agri-Starter** to partially filled planter tank and complete filling process. A small amount of agitation is suggested for thorough distribution. When mixing in a batch tank, add product to water or nitrogen solution before adding phosphate material.

### RECOMMENDED RATES

#### Broadcast Application

Severe Deficiency . . . . .	4 qts. per acre
Moderate Deficiency . . . . .	2 qts. per acre
Maintenance . . . . .	1 qt. per acre

**Row Application:** Use at a rate of two quarts per acre as a supplement to broadcast applications, preferably of an inorganic micronutrient source.
